The United Technical Center School of Practical Nursing is operated by the administrative council of Doddridge, Harrison, and Taylor counties as a postsecondary program. The course is sponsored by the State Bureau of Vocational, Technical, & Adult Education and is accredited by the West Virginia State Board of Examiners for Licensed Practical Nurses and the Commission of the Council of Occupational Education.

Practical Nursing offers a variety of attractive career opportunities. Students are prepared to hold positions in nursing homes, doctor's offices, hospitals, home health, and penal institutions. The role of the LPN includes giving direct bedside care, administering medications and treatments, reporting and recording client responses, and working in a team relationship with registered nurses, physicians, and others.

Graduation from the program qualifies the student to take the national licensing examination (NCLEX-PN).

Admissions

*Classes begin on July 1 of each year and continue through the end of June of the following year.

*Must be a high school graduate or GED/TASC and be 17 years old by the first day of school.

*Register and take the pre-entrance TEAS VII test with a composite score of 60%. A free TEAS review course is offered; call for information to register.

*Submit application and include 3 letters of reference, school transcripts, and complete interview with the faculty.

*Fulfill other requirements if accepted (physical exam, lab titers, vaccinations, drug screen, and background checks).

WV State Police background checks are conducted on all accepted students and are subject to review by the WV State Board of Examiner's for LPN review. Information obtained from background checks is made available to clinical agencies as required

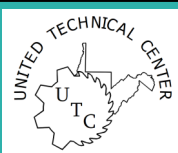
